BLAZIN' 102.3'S "UNIVERSAL ORLANDO RESORT MARDI GRAS" CONTEST OFFICIAL RULES

The Station will conduct the **Blazin' 102.3's "Universal Orlando Resort Mardi Gras"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - **Eligibility.** This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 60 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 60 days. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest entry period will begin at 3:00PM ET on Tuesday, March 7, 2023 and will run Tuesdays, Wednesdays, and Thursdays from 3:00PM ET until 7:00PM ET through Thursday, March 30, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station during the Contest Period. Once each Tuesday, Wednesday and Thursday (each, a "Selection Day"), when the Station plays the Contest sounder (each, the "Sounder"), listeners must call the Station at (850) 201-1023. Caller #10 to the Station, as determined by the Station in its sole discretion, will be the qualifying winner (each, a "Qualifier")) for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE QUALIFIER PRIZE PER PERSON.**
- 4. **Grand Prize Winner Selection.** On or about 3:00PM ET on Tuesday, April 4, 2023, the Station will select one (1) grand prize winner in a random drawing from all Qualifiers. The grand prize winning Qualifier will be contacted using the email address and/or telephone number provided when becoming a

Qualifier and may be awarded the grand prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5.
